#### **59 Correspondence**

Consideration was given to the following:-

59.01 Parking issues outside the school/bowling club- Various options regarding the parking problem outside the school was discussed. Staggered times for collection of the younger children was suggested as they do in Ysgol Bro Siôn Cwilt and a foot bridge/concrete culvert from the car park to school(passed the bowling club). The Clerk had reported that Ann Lloyd had contacted her for the opinion of the TC. She would inform her that Councillors' would be on site to discuss and support her options

59.02 Various issues with waste collection/bins in the Town – the possibility of a pilot scheme in New Quay similar to the one recently adopted by Tregaron Town Council/Collection of bins skateboard park/tennis court – fee to pay CCC- Bins had been returned except for the surgery. Further information regarding the Tregaron TC scheme would be requested together with information from Aberaeron TC regarding their employment of a street cleaner. Members were of the opinion that this was the way forward to clean and tidy the town due to the financial pressures on the County Council. A charge for the collection of the bin ouside the skatboard park would be requested from CCC, and that the football club were liable for the charge for the bin in the tennis court.

59.03 The possibility of a public meeting to discuss the issues of concern of residents in the Ward /Questionnaire circulated in the Town prior to meeting- It was agreed that a notice be placed in the Cambrian News/Facebook requesting residents feedback on which issues they wish to be addressed in the Town. Feedback could be sent to the Clerk or County Councillor via email/post or taken to Sheffield House. A meeting would then be arranged in the memorial hall.

59.04 Issues regarding manholes- had been resolved.

## **61 Urgent items – discretion of the Chair**

61.01 An update regarding the memorial hall was provided and that the committee had now agreed to accept the terms of the lease following receipt of the building survey

61.02. A letter had been received from the residents of Brongwyn lane, it was agreed to inform CCC that the TC could not consider the request as they were awaiting the new lease for Maesypwll. Councillor J Evans had requested the contractor to cut only one side of Maesypwll; as it was not financially viable to cut the steep slope.

61.03 Sandy Slip Toilets – Closed in August by the cleaner as they were unclean, also closed May Bank Holiday, recently the cleaner was cleaning weekly since early September. The window had blown open and had flooded the gents toilets.Councillor Potter would contact the relevant officer to discuss these issues.

61.04 Beach by Penpolion –Concerns were raised by Councillor J Davies that the chains were exposed at end of the Sandy Slip and the problems of launching and recovery of dinghies/Sups. She also requested clarification if the mud affected the water quality as there was deep pools of mud by penpolion, and queried if this was result of overenthusiastic dredging. Other Members with experience of the slip were of the opinion that this was a natural occurrence and not due to dredging.

61.05 Councillor Davies reported that there were weeds behind the dingies and around Kayaks on the Sandy Slip, budlia on the wall above the Sandy Slip toilets, trees overgrown above the watersports compound. It was agreed that these were issues that could be considered if the Council employed/contracted work.

61.06 It was reported that the shells on the beach had created a ridge and requested if the ridge could be removed. Members were of the opinion that if it was removed, it would return.

61.07 Councillor Davies requested if the sand could be raked due to small items in the sand, this request had been refused on previous requests due to legislation, however, Councillor Potter would contact CCC on a solution

He reported that Cabinet had agreed at its meeting in September that the offer of the £30,000 corporate funding was withdrawn; and the Council ceases to subsidise the Hall in its corporate capacity on 31/03/2018. Due to this decision several of the users of the hall were concerned regarding their future. Additional Members on the Committee and assistance was required in the future if the hall committee wished to apply for grants.

The New Quay Memorial Hall had requested that a letter of support be sent to Town Council to the Charitable Commission.

Julian Evans vacated the room during consideration of this request. Several Members were of the opinion that residents were not aware of the position of the hall; and that there was a need to advertise on social media, Cambrian News and posters around the Town the need for new Members on the committee; and assistance in running the hall. Prior to agreeing in sending a letter of support to the Charitable Commission, the Clerk would circulate the letter for comment. It was also noted that Julian Evans had contacted the local school to enquire if any of their staff could be members of the committee as they were one of its main users. It was suggested that the Cambrian News be contacted to attend the Christmas school play to obtain a photograph and write an article on the need for volunteers and memorial hall committee members.

Clarification was sought from Councillor J Evans regarding the assistance Menter Cei Newydd had provided to Pontgarreg Hall as he had recently visited the hall to provide defibrillator training, and had been informed that Councillor Hopley had assisted their hall

**Ambulance Station – New Quay**

The Chairman welcomed to the meeting Mr Brian Pullen, Locality Manager and Mr Rob Jeffery, Area Operations Manager, Hywel dda. They informed Members that they wished to attend to provide members with an update on the Ambulance Station in New Quay. The Station had now become to the end of its life and not fit for purpose, also as the porter cabin was a temporary measure, no further planning applications could be submitted on this site. Mr Pullen also stated that the Fire brigade site could not accommodate both services; therefore one of their options was a station as part of the new Integrated Centre in Aberaeron as the land was free. He emphasised the station was just a building and a location to collect and hand over the ambulance. Concerns were raised by Members that the ambulance could not meet its target in New Quay of eight minutes. In response, the Locality Manager stated that the eight minutes was not viable in several areas not even Aberystwyth where a station was located as they were responding when mobile. Mr Jeffrey reported that the vision of the service and the health board was prevention and that Integrated centres could serve the residents of the community before there was a need for an ambulance, this was already done in the Tregaron area. To accommodate the concerns of Members regarding the population increasing in the summer, it was proposed that a paramedic would have a suitable base in New Quay. A Co responder vehicle was also seen as a viable option in New Quay and it was reported that that Station Manager for NQ Fire Station was currently considering this option. The RNLI station was also seen as a suitable location to train and support the community in first aid.

It was suggested that a portacabin could be located at the top of Church St Car park. In response, Mr Pullen reported that they wished to move away from portacabins and provide their employees with a suitable building for their needs and training.
