Any Other Business – under the discretion of the Chair

108.01 The Clerk had sent an email to the Working NQ group regarding the Refill scheme. It was reported that there were two businesses already in the scheme the Black Lion and Watersports centre. She reported that she had received an email from the owner of the Corner shop who was against the scheme as he was selling plastic bottled water, and felt this scheme would impact on his sales of water. The Clerk reported that the scheme was aimed at people that were visiting New Quay with refill bottles and to assist Plastic Free New Quay. She had used the scheme at several cafés in Cardigan and Aberystwyth and had purchased other items in the café following a refill of her bottle. Therefore the scheme could encourage more business in these cafés. A request to install the well in the park was also seen as an option and the County Councillor would contact the County Council.

108.02 Concerns were raised that there had been no bus service into New Quay over the Bank Holiday. It was agreed to contact the Corporate Transport Unit at Ceredigion CC for confirmation if there would be a service during the forthcoming bank holidays.

108.03 The Clerk reported that last year during the regular Sunday clean ups with Charles Harvey from Wildcove, pickers and hoops had been provided by the County Council. They had agreed that a set would be
