**70 To reconsider the precept for 2024/25
following the meeting held with the
Leader and Chief Officers of
Ceredigion County Council regarding
devolving their services to New Quay
Town Council**

Members discussed the proposals by
Ceredigion County Council to devolve the
grass cutting tender, street maintenance and
public conveniences to New Quay Town
Council. Following detailed discussion and
the resetting of the budget to accommodate
the cost of the grass tender and street
maintenance only, it was AGREED to
increase by precept to £38,260.00, which
would equate in total to £3.46 a month per
household (an increase by the sum of £1.81)
(for a property in Band D)

The Clerk would advertise the tenders and
would send them to Members to approve
prior to circulating.
