#### **66 Minutes of the Meeting held on 26 November 2018**

66.01 The Minutes of the meeting held of the 26 November 2018 were confirmed as a true record.

66.02/57.02/48.01/39.02/29.03/19.09/10.03 Awaiting paint to paint the bollards and benches

66.03/57.03/48.03/39.06 An email had been received from Ceredigion Museum, stating that the responsibility of the repair of the toll boards was NQTC as previously grants were available for their repair. It was agreed that three quotes/tenders would be sought for their repair. It was also reported on the need to replace the wood for the Dylan Thomas board, it was also agreed to seek three quotes for its repair as there were monies ring fenced in the NQTC bank account.

70.01 Precept 2019/10- Detailed consideration was given to the budget to agree the precept for 2019/10. Following discussion it was agreed that the precept remain at £16,072.64 as the Council had been criticised on the amount of reserves in their account.

### **72 Urgent items – discretion of the Chair**

72.01 Soap Box Derby- It was agreed that a donation be given; however, the views of residents would be sought on the event. Clarification on the time of the road closure together with the payee on the donation cheque would also be requested from the event organiser.

72.02 It was reported that the current lease holder was revoking their lease for the Paragon Offices. It was agreed that the clerk would contact the Welsh Ambulance Trust to inform them that there was a suitable location available for the ambulance in New Quay.
