Councillor Vaux stated that he was willing for a point on his business, the Captains. It was reported that the two businesses had turned the points off as they thought this had an impact on their wifi, but the installer had informed Cllr Sioned Davies that this was not the case as the Watersports centre did not experience any issues, and also had the most

88.04/79.04/71.04 No update on Place Plan following several emails from Councillor Vaux. The Corporate Manager, Growth and Enterprise had informed Councillor Vaux that he would be in contact soon to discuss this further.

88.05/83.02 A map had been received and Penwig park was a village green, therefore Members queried if it was possible to charge for use of this land, as was the case with the land surrounding the old TIC. Also, from the map Church Street car park was also a village green, therefore clarification would be sought regarding parking charges. Councillor Vaux would seek confirmation on these issues.

88.06/80.01 Skateboard Park- the Clerk and Councillor Vaux had been in correspondence with a parent regarding the cleaning/tidying of the park and details of a company which could also quote to replace the skateboard park equipment. However, to date no further correspondence had been received following the offer of assistance and trailer to dispose of the weeds from Councillor Vaux . A committee was due to be formed to proceed with the funding of the Skateboard Park.
