22 Correspondence

22.01 Training – One Voice Wales- email circulated with the available courses.

22.02 Skateboard park – it was reported that during the place plan meeting with officers of CCC, they were of the opinion that the proposed pump track should be relocated from the car park, it had been suggested that a piece of land at the end of the football field could be an option.

22.03 Place Plan – Councillor M Vaux and Clerk had attended the walkabout with the consultants and officers from CCC for them to ascertain the structure, Council assets etc of the town for further consideration within the place plan. It was proposed that a public meeting with public, stakeholders and businesses would be held early September.

23 Any Other Business

23.01 Concerns were reiterated regarding the vast amount of refuse produced by the takeaway establishments that continued to block the bins and people placing them all round the bins when full. A letter had been sent, however, another establishment had now started using boxes, therefore a letter would also be sent to them requesting that they reconsider their packaging. It was also agreed that a Council bin from the cnwc be relocated outside the Lime Crab do assist with their refuse to alleviate the need for their customers to use and overload the bin by the shelter.
