54 County Council Report

The consultation on the Council Tax Premium for Long-Term Empty Properties and Second Homes in Ceredigion had ended. 1,403 responses had been submitted. The consultation had been considered by a cross party working group, however, they had not provided a recommendation for Cabinet/Council to consider. The Cabinet would consider the item on the 05 December and Council on the 14 December.

The responses to the Harbour Management Policy had been completed and required reviewing, this also would be presented in due course to Cabinet. A number of unhappy commercial users had concerns with the proposals of the new Policy, which required addressing.

The new Community Housing Scheme was outlined to the Council.
